

2019 Paramedic Competition

Equipment Guidelines

Each team's equipment will be inspected by an OEMS staff member before the competition. Equipment not allowed by these guidelines will be removed prior to team competition. The final decision to allow or disallow any equipment will rest with the OEMS.

No cell phones, PDA's, smart watches, pagers, radios, or other such electronic devices will be allowed in the competition area. These items should be secured in your room or vehicle or left in the holding area.

No weapons will be allowed at the competition site. Other site-specific requirements may apply.

General Equipment

1. The attached equipment list is divided into two categories:
 - equipment provided at each site (*On-site Equipment*), and
 - equipment allowed by teams (*Allowed Equipment/Medications*).**Items not shown in either category are not allowed for use in the competition.**

Please note: Teams may elect to bring their own monitor/defibrillator or the site will have a monitor/defibrillator with 12 lead capabilities for teams unable to bring one. With the exception of a monitor/defibrillator, **teams will not be provided any other items on the *Allowed Equipment/Medications* list. Only 1 monitor will be allowed.**

2. No mechanical CPR or ventilation devices will be allowed. **CPAP equipment/supplies are available for use at each site.**
3. All IV tubing, catheters, and solution sets must be kept separate (no pre-spiked bags).
4. Oxygen tanks may be empty. Teams will be required to place the delivery device near the patient's mouth (or around the neck) and verbalize the flow rate. **Teams may utilize no more than two oxygen bottles with regulators. Multi-patient oxygen delivery systems will not be allowed.**
5. No charts, medication references, rulers, measuring or counting device, or calculators will be allowed. Teams may bring one length based pediatric assessment device.

Medications

1. Medications do not have to be the actual drug preparation (can be water/saline); however, each medication package must be labeled with the concentration and name. All fluids and medications will be assumed to be "in-date" regardless of the expiration date shown on the label.
2. Each medication must be in its original packaging or stored in a comparable manner (i.e. saline vial can be labeled as any medication typically packaged in a vial).
3. Premixed intravenous medications (e.g. Lidocaine or Dopamine) may be used if properly labeled as above.
